GEG – development of the Klinikum Bremen-Mitte GmbH & Co. KG site

GEG is developing the new Hulsberg neighbourhood in a central location in Bremen. It is selling the former plots of the Bremen-Mitte Clinic to third parties so that they can construct building projects. GEG has already sold over 40 per cent of the gross floor area that can be realised for the exciting mix of residential and commercial uses. Next steps in the neighbourhood development: In autumn 2024, GEG will start building roads, squares and technical infrastructure, in summer 2025 the primary school in the new Hulsberg district will start operating, while GEG will continue to sell further plots in parallel. Currently on offer is the historic skin clinic together with a plot on which the "FRIEDRICH" mobility centre is being built. In addition, an elaborately coordinated sales process is being initiated for several plots of land that are being addressed exclusively to private building cooperatives. The new district with around 1,000 residential units, commercial facilities, a school, daycare centres and a training academy for nursing professions will be completed over the next five years.

Steingut Projekt GmbH & Co. KG, a joint venture of PROCON Realisierungsgesellschaft mbH and M-Projekt GmbH & Co. KG, has acquired the approximately 10-hectare site of "Norddeutsche Steingut AG" in Bremen-Grohn.

The development of this site into a new urban quarter with a mixed use of commercial and residential space, following the concept of the "productive city," represents a major opportunity for the district. Its central location in Bremen-North, excellent connections to public transport (Bremen-Schönebeck railway station), the A270 motorway, and immediate proximity to Constructor University Bremen and the Science Park underline the potential of the former industrial site.

The joint concept developed by the Berlin architects Schönborn Schmitz Architekten and the landscape architecture firm Querfeldeins won the urban planning competition for the 10-hectare Steingut Quarter.

The former industrial site has been cleared, while two building sections have been preserved and are now being repurposed under the project names "Bestandserhalt Süd" and "Bestandserhalt Nord." New construction will gradually take place on the remaining areas of the site. The subprojects include:

- Bestandserhalt Süd: daycare center, medical practices, and an intensive care facility
- Bestandserhalt Nord: commercial use and an event hall
- Carré 5: mixed use with commercial, gastronomy, and residential space (in planning)
- Carré 6: mixed use with commercial and residential space (student housing, in planning)
- Solitär 1 and 4: mixed use with commercial and residential space (in planning)
- Solitär 2: subsidized housing to provide affordable living space
- Solitär 3: privately financed residential development (in planning)
- KiTa Süd: another daycare center for the Hans-Wendt-Stiftung, construction already underway
